Name of Service Being Provided

Heart Children Ireland is a support group for parents and families of children born with Congenital Heart Defects. We also support children with acquired heart disease.

The Management and Board of Heart Children Ireland have agreed the Child Safeguarding Statement set out in this document.

Nature of organisation and principles to safeguarding children from harm

As an organisation, Heart Children Ireland is committed to the safety and wellbeing of children and young people who participate in Heart Children Ireland events, and to ensuring they are safeguarded from harm. All Heart Children Ireland staff are appropriately vetted by the organisation and Garda Vetted. In addition all staff attend the necessary workshops/seminars conducted in relation to Child Safeguarding. All volunteers with access to children are Garda Vetted and made aware of Heart Children Ireland's Child Protection Policy.

In our Safeguarding Policy Document Heart Children Ireland provides information and best practice in relation to the following:

- Categories and definitions of Child Abuse
- Recognising abuse
- Dealing with a disclosure
- Reporting abuse
- Heart Children Ireland's procedures for dealing with allegations of abuse
- Codes of behaviours when carrying out duties associated with Heart Children Ireland.

Heart Children Ireland - who we are and what we do:

Heart Children Ireland is a support group for parents and families of children born with Congenital Heart Defects. We also support children with acquired heart disease.

Here are just some of our activities

- 1. Through our News Briefs, we provide updates about Heart Children Ireland services and supports, as well as relevant information about health service matters.
- 2. We provide a Family Psychology Support Service free to all members. Families supporting individuals with congenital heart conditions, adults with congenital heart conditions and bereaved families access this service.
- 3. We host social events where parents can meet and talk.
- 4. We hold an annual conference with keynote speakers from the world of congenital cardiology.
- 5. We have purchased lifesaving equipment for the Children's Heart Centre at Our Lady's Children's Hospital.
- 6. We purchased the first ECMO machine for the Intensive Care Unit at this hospital. This machine is saving lives on a daily basis.
- 7. We have purchased 18 Oxygen Saturation Monitors for the Cardiac Unit at Crumlin. These machines enable young babies to spend more time at home than they might otherwise do so.
- 8. We have provided 30 Coagu-Chek machines for our young heart children. We recently provided our 75th machine for a young adult at The Young Adult Congenital Unit at the Mater Hospital.

- 9. We have provided a dedicated clinic room for the Young Adult Congenital Unit at the Mater Hospital to facilitate our teenagers transferring from Crumlin Hospital.
- 10. We are privileged to manage The Blue Ribbon Fund on behalf of the Moran family. This fund provides assistance to families on the transplant journey with their child. This fund is in memory of Elaine Moran.

Risk of harm to young persons at Social Events held by Heart Children Ireland, e.g., Summer Picnics, Christmas Parties, fundraising events.	Parents/Guardians present at all times at Heart Children Ireland Social Events. Parents encouraged to read Heart Children Ireland's Safeguarding Statement.
Risk of harm to young people attending Crèche facilities at Heart Children Ireland's Annual Conference/Family Support Days Nationwide	Crèche personnel fully trained and Garda Vetted. Crèche personnel aware of Heart Children Ireland's Safeguarding Statement.
Risk of harm to a young person attending Heart Children Ireland's Family Psychology Support Service	Clinical Psychologist Garda Vetted and aware of Heart Children Ireland's Safeguarding Statement. Clinical Psychologist is a Mandated Person as defined by The Children First Act 2015
Risk of harm to a young person attending fundraising photo shoots.	Organiser aware of Heart Children Ireland's Safeguarding Statement. Organiser Garda Vetted.

It should be noted that risk in the context of this risk assessment is the risk of "harm" as defined in the children First Act 2015 and not general health and safety risk.

The Management and Board of Heart Children Ireland, in undertaking this Risk Assessment, have endeavoured to identify as far as possible the risks of harm that are relevant to Heart Children Ireland and to ensure that adequate procedures are in place to manage all risks identified. While it is not possible to foresee and remove all risks of harm, Heart Children Ireland has in place the procedures listed in this Risk Assessment to manage and reduce risk to the greatest possible extent.

Heart Children Ireland recognises that implementation is an ongoing process and is committed to the implementation of this Safeguarding Statement and the procedures that support Heart Children Ireland's intention to keep children we come in contact with safe from harm.

This Safeguarding Statement will be reviewed on an annual basis by the Board of Heart Children Ireland, or as soon as practicable after there has been a material change in any matter to which this statement refers.
